Re: School Bus Transportation for the 2010/11 School Year

Earlier this month you should have received a letter stating the likelihood of no longer having bus transportation available for the next school year (2010/11). We are still attempting to find a solution other than eliminating bus transportation; however, **your feedback is important and necessary**.

The option of providing very limited bus service is being evaluated. Should such an option become available, there would be fewer stops than we currently have and the majority of the stops would be beyond a one to two mile radius from the school.

Please reply to the questions on the next page. If we do not receive responses from the majority of the parents of our existing riders, we will assume that bus transportation is not a major concern and we will discontinue our effort to find a possible bus transportation solution for next year.

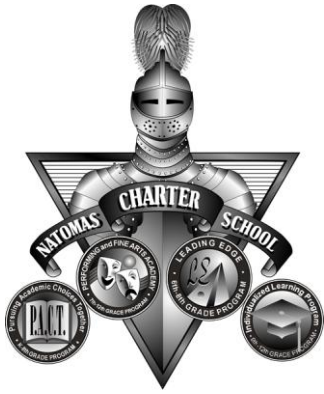
If we move in the direction of limited bus service, we will have some flexibility on creating approximately six pick-up and drop-off locations or stops. At this time we are considering the following general stops:

- ***American Lakes Elementary School***
- ***Jefferson Elementary School***
- ***Two Rivers Elementary School***
- ***NP3 and Westlake Charter School***
- ***Intersection of Myotis and Jackdaw***
